## **NATIONAL**

- Fertiliser major IFFCO announced that it has been ranked as the biggest cooperative in the world by 'Word Cooperative Monitor' report 2018.
- According to a report named QS Asia University Rankings 2019 by Quacquarelli Symonds, India doubled their presence in the ranking. India has the third largest number of universities and institutes (75), after mainland China (112) and Japan (89).
- According to a report titled 'Nation Brands 2018' released by Brand Finance, India has secured ninth rank out of top 50 valuable national brands.
- India's first engine-less train, "Train 18", developed by the Integral Coach Factory (ICF) and seen as a successor to the prestigious Shatabdi Express, was unveiled by Railway Board Chairman Ashwani Lohani.
- PM Narendra Modi inaugurated Sardar Vallabhbhai Patel's memorial on the leader's 143rd birth anniversary in Gujarat's Narmada district. Called the Statue of Unity.
- India will become the world's third largest aviation market around 2024 surpassing the UK, according to global airlines' body International Air Transport Association (IATA).
- The Supreme Court ruled that no Bharat Stage-IV vehicle shall be sold across the country with effect from April 1, 2020.
- Angriya, India's first luxury cruise ship, has been inaugurated at Mumbai.
- The government has announced 100 crore rupee award for states that would complete the household electrification early under the Saubhagaya scheme.
- Minister of State for Textiles, Ajay Tamta has stated that the Ministry will release 7.8 crore rupees for the construction of a textile tourism complex in Nongpoh, Ri-Bhoi district of Meghalaya.
- The country's first India-Israel Innovation Centre (IIIC), an entrepreneurial technology hub, was launched in Bengaluru.
- The country's biggest skill competition, India Skills 2018 was held in New Delhi.
- The Centre has assured Karnataka government that nearly 450 crore rupees will be reimbursed to it in connection with the expenditure incurred for procuring cereals and coarse cereals.
- The Election Commission has announced the poll schedule for Assembly elections in Madhya Pradesh, Mizoram, Rajasthan, Chhattisgarh and Telangana.
- Assam launched launched Asia's first cannisters based Methanol Cooking Fuel Program.
- As many as 21 countries in the Indian Ocean Rim Association, IORA, adopted the Delhi Declaration on Renewable Energy in the Indian Ocean Region.

- The Prime Minister, Narendra Modi, inaugurated the first Assembly of the International Solar Alliance in New Delhi.
- Kolkata Municipal Corporation (KMC) launched a Flood Forecasting and Early Warning System (FFEWS) for Kolkata City.
- A parliamentary panel headed by Kirit Somaiya will examine the functioning of retirement fund body Employees Provident Fund Organisation (EPFO), its coverage and recovery of arrears.
- The Union Government constituted a fourmember Group of Ministers headed by Rajnath Singh to examine and strengthen the existing legal and institutional frameworks for dealing with matters of sexual harassment of women at the workplace.
- Odisha government launched the State's own food security scheme to cover the poor people.
- The Government constituted a seven-member ministerial panel headed by Bihar Deputy Chief Minister Sushil Modi to examine modalities for revenue mobilisation in case of natural calamities and disasters.
- In pursuance of its objective of ensuring that Legislation is in sync with the needs of strong economic fundamentals, the Government has constituted a Competition Law Review Committee to review the Competition Act. The Committee was headed by Injeti Srinivas.
- ICGS Varuna, an indigenously-designed training vessel built by Reliance Naval and Engineering Limited for the Indian Coast Guard, was launched in Pipavav.
- North Atlantic Treaty Organization's (NATO) biggest military manoeuvres since the Cold War was held in Norway.
- India, Japan and the U.S. are set to elevate the bilateral 'Cope India' air exercise to a trilateral format
- India and Japan are all set to hold the first-ever joint military exercise 'DHARMA GUARDIAN-2018' involving the Indian Army and Japan Ground Self Defence Force in Mizoram.
- The sixth edition of IBSAMAR, a joint Multi-National Maritime Exercise between the Indian, Brazilian and South African Navies, was held at Simons Town, South Africa.
- Shahi Litchi of Muzaffarpur, Bihar has got official recognition as it receives the geographical indication (GI) tag.
- Alphonso Mango from Ratnagiri, Sindhudurg and other adjoining areas in Maharashtra, got a Geographical Indication (GI) Tag.
- The cabinet has approved the new telecom policy, now named National Digital Communications Policy (NDCP) 2018, which aims to attract USD 100 billion investment and create 4 million jobs in the sector by 2022.

- The Supreme Court declared the Centre's flagship Aadhaar scheme as Constitutionally valid. The Supreme Court ruled that linking the Aadhaar card to PAN card is mandatory and is needed for filing income tax returns. The apex court, however, said Aadhaar is not mandatory for opening bank accounts and linking with existing accounts.
- Prime Minister Narendra Modi has launched Ayushman Bharat - Pradhan Mantri Jan Aarogya Yojana from Ranchi, Jharkhand. Under this scheme, over 10 crore families will be provided health assurance worth five lakh rupees each, every year.
- The Union Cabinet has approved an ordinance making triple talaq a punishable offence.
- The Union Minister for Railways and Coal, Piyush Goyal inaugurated the 'first ever' India Tourism Mart (ITM 2018) in New Delhi.
- The Prime Minister, Narendra Modi, launched the 'Swachhata Hi Seva' Movement, to boost nationwide public participation in the Swachh Bharat Abhiyan, and catalyse the fulfilment of Mahatma Gandhi's dream of a Clean India.
- The National AIDS Control Organisation (NACO) released the report HIV Estimations 2017. As per the report, Maharashtra has the highest number of people living with HIV in India. Andhra Pradesh and Karnataka were on second and third place, respectively.
- The Union cabinet approved a proposal for the complete electrification of Indian Railways by 2021-22, reducing dependence on imported fossil fuel and saving revenue for the national carrier.
- The Ministry of Health and Family Welfare has announced the implementation of the Human Immunodeficiency Virus (HIV) and Acquired Immune Deficiency Syndrome (AIDS) (Prevention and Control) Act, 2017.
- The act criminalises any kind of discrimination against people suffering from AIDS in terms of treatment, employment and workplace.
- The first of its kind university in the country in the transport sector, the National Rail and Transportation Institute (NRTI), started operations in Vadodara.
- The first ever mid-air refuelling of the indigenously developed light combat aircraft Tejas was successfully carried out, placing India in an elite group of countries having air-to-air refuelling capacity for military planes.
- The Supreme Court abolished Section 377 of the Indian Penal Code (IPC), the 1862 law which criminalised homosexuality.
- Minister for Commerce & Industry and Civil Aviation, Suresh Prabhu launched Coffee Connect - India coffee field force app and Coffee KrishiTharanga - digital mobile extension services for coffee stakeholders at a function in New Delhi.
- The Union Ministry of Micro, Small and Medium Enterprises (MSME) approved a proposal by the Khadi and Village Industries Commission (KVIC) to increase the wages of artisans by over 36%.

- The National Nutrition Month (September) is being celebrated across the country to mark the fight against malnutrition.
- NITI Aayog Chief Executive Officer Amitabh Kant announced that India will shortly unveil a One Nation-One Card policy for public transport that will entail connectivity between various modes of transport.
- India along with 23 other nations participated in a major Indian ocean-wide tsunami mock drill which will involve evacuation of thousands of people from coastal areas in over half a dozen coastal states.
- Rima Das' National Award-winning feature Village Rockstars has been chosen to represent India in the Best Foreign Language category at the 91st Academy Awards next year
- In order to fight the growing problem of counterfeit drugs in India, NITI Aayog and Oracle signed a Statement of Intent (SoI) to pilot a real drug supply-chain using blockchain distributed ledger and Internet of Things (IoT) software.

India And UN Signed A Five-Year Sustainable Development Framework for 2018-2022

- The government of India-United Nations Sustainable Development Framework (SDF) 2018-2022 outlines the work of UN agencies in India, to support the achievement of key development outcomes that have been identified in consultation with the government and are aligned to the national priorities.
- BSNL has inked a pact with Japan's Softbank and NTT Communications to roll out 5G and internet of things (IoT) technology in India.
- Ministry of Health and Family Welfare, exchanged the MoUs with the Tata Trusts and Dell to provide a technological platform for nation wide prevention, control, screening and management program of Non-Communicable Diseases (NCDs).
- The Ministry of Home Affairs (MHA) and Indian Space Research Organization (ISRO), Department of Space signed an MoU for setting up of an state-of-the-art Integrated Control Room for Emergency Response (ICR-ER) in Ministry of Home Affairs.
- Cisco, a U.S.-based firm, that makes networking telecommunications equipment, has signed two agreements with the NITI Aayog and Bharat Sanchar Nigam Limited (BSNL) to speed up its Country Digital Acceleration programme in India.
- NITI Aayog, Intel and Tata Institute of Fundamental Research (TIFR) are collaborating to set up a Model International Center for Transformative Artificial Intelligence (ICTAI).
- Minister of State (Independent Charge) for Housing and Urban Affairs, Hardeep Singh Puri inaugurated the first regional workshop on RERA (Real Estate (Regulation and Development) Act) in Pune.
- Union Minister for HRD Prakash Javadekar Inaugurates 4th World Summit on Accreditation (WOSA-2018) at New Delhi.

- Prime Minister Modi inaugurated India's first Global Mobility summit 'MOVE' in New Delhi.
- A Conference on "E-Mobility in Indian Railways" organized by Ministry of Railways through Institution of Railways Electrical Engineers (IREE) in association with NITI Aayog concluded in New Delhi.
- The government has set up an eight-member Lokpal Search Committee under the Chairmanship of former Supreme Court Judge, Justice Ranjana Prakash Desai.
- The Employees' State Insurance Corporation (ESIC) has approved a new scheme- Atal Bimit Vyakti Kalyan Yojna for Insured Persons covered under the Employees' State Insurance Act. This scheme is a relief payable in cash directly to their Bank Account in case of unemployment and while they search for new engagement.
- The third edition of World's Biggest Open Innovation Model - Smart India Hackathon 2019 was launched by the Union Minister for Human Resource Development, Prakash Javadekar in New Delhi.
- India's largest business incubator the Bhamashah Techno Hub was inaugurated in Jaipur.
- The Supreme Court ruled that the 'None of The Above' (NOTA) option will not be applicable for voting in the Rajya Sabha elections.
- With an aim to provide country's poor access to quality and affordable healthcare, government on announced the launch of Ayushman Bharat (now Jan Aarogya Abhiyan) covering 50 crore people.
- The Statistics from 14 cities across India have been analysed for clean and low carbon mobility and the title reported 'The Urban Commute'
- Bhopal tops for lowest overall emissions and energy use.
- Kolkata emits least among six megacities due to high usage of public transport and walking.
- The Ease of Living Index 2018 was released by Union Minister Hardeep Singh Puri. Of total 111 cities ranked under the index, Pune has been ranked first while Navi Mumbai has surfaced as the second preferred spot in terms of 'liveability'.
- India has jumped 22 places to 96th rank to break into the top 100 of the United Nation's E-Government Development Index (EGDI) 2018. Denmark, with an index value of 0.9150, topped the 2018 E-Government Development Survey.
- India successfully flight tested the indigenously developed helicopter launched Anti-Tank Guided Missile 'HELINA' from Pokhran in Rajasthan.
- Exercise 'Maitree' 2018 is a joint military exercise between Indian Army and Royal Thai Army which is held in Thailand.
- Union Water Resources Minister Nitin Gadkari signed an MoU with six states for the construction of the Lakhwar multi-purpose project in the upper Yamuna basin to deal with water crisis.
- The Centre unveiled a draft scheme for extending the affordable air travel programme UDAN to international circuits, with state governments identifying the routes for operation.

- Government has approved 122 new research projects of 112 crore rupees under its Impacting Research Innovation and Technology 'IMPRINT-2' scheme. The initiative aims to advance research in energy.
- Santhali (Santali), a tribal language primarily spoken in India, Bangladesh and Nepal, received global recognition when it got a Wikipedia edition in its own script.
- The Union Government has unlocked green funds worth over Rs.66,000 crore to increase the country's forest cover.

The Global Innovation Index 2018 was launched in New Delhi by Ratan P Watal, Principal Adviser, NITI Aayog. India's rank on the Global Innovation Index (GII) has improved from 60 in 2017 to 57 in 2018.

- The Global Innovation Index (GII) provides detailed metrics about the innovation performance of 126 countries which represent 90.8% of the world's population and 96.3% of global GDP.
- The Khangchendzonga Biosphere Reserve (in Sikkim) has become the 11th Biosphere Reserve from India that has been included in the UNESCO designated World Network of Biosphere Reserve.
- The 123rd Constitutional Amendment Bill giving constitutional status to the National Commission for Backward Classes (NCBC) has got Parliamentary assent.
- AIBD India has been elected as the President of the Asia-Pacific Institute for Broadcasting Development (AIBD) for a period of two years.
- Google announced Project Navlekha at its 4th edition of Google for India Event held in New Delhi.
- Former President Pranab Mukherjee launched the National Electoral Transformation (NETA) mobile application to rate Members of Parliament (MPs) and Members of Legislative Assembly (MLAs).
- NITI Aayog has launched "Pitch to MOVE" a mobility pitch competition that aims to provide budding entrepreneurs of India a unique opportunity to pitch their business ideas to a distinguished jury.
- The Union Home Minister Rajnath Singh has rolled out the Smart City projects that will help New Delhi emerge as a world-class city.
- The Ministry of HRD has embarked on a major and new initiative Project called 'Study Webs of Active Learning for Young Aspiring Minds' (SWAYAM), which will provide one integrated platform and portal for online courses. This covers all higher education subjects and skill sector courses.
- Startup India has launched the Startup Academia Alliance programme, which is a unique mentorship opportunity between academic scholars and startups working in similar domains, to fulfill the Indian Government's mission to promote the spirit of entrepreneurship in the country.

- Commerce and Industry Minister Suresh Prabhu launched a logo and tagline for Geographical Indications (GI) to increase awareness about intellectual property rights (IPRs) in the country. The slogan for the GI tag is- 'Invaluable Treasures of Incredible India'.
- The IT ministry launched a desktop software e-Aksharayan in a conference for Indian Languages Technology Industry 'Bhashantara', in New Delhi.
- Inland Waterways Authority of India (IWAI) made public 13 standardised state-of-the-art ship designs suitable for large barge haulage on river Ganga (National Waterway-1).
- The Cabinet Committee on Economic Affairs chaired by Prime Minister Narendra Modi gave its approval for implementation of an umbrella scheme 'Ocean Services, Technology, Observations, Resources Modelling and Science (O-SMART)'.
- A National Viral Hepatitis control programme aimed at eliminating the deadly condition by 2030 was launched by the Ministry of Health and Family Welfare in collaboration with the World Health Organisation.
- The government has decided to set up a committee under the Chairmanship of Mr Anil Swarup, to suggest measures to strengthen National Cadet Corps (NCC) and National Service Scheme (NSS).
- The Madhya Pradesh State Government launched an outstanding power bill waiver scheme and subsidised power scheme called 'Sambal' for labourers and poor families.
- The government has set up a 13-member committee to upgrade the norms for computation of economic data at states and districts level in the backdrop of plans to revise the base year for National Accounts or GDP calculation.
- According to the US-based Institute for Energy Economics and Financial Analysis (IEEFA) report, Karnataka is the new national leader in renewable energy generation.
- According to the Public Affairs Index 2018, Kerala is the best-governed state in the country.
- Haryana has topped other states in per capita revenue collection under GST and is also the fourth highest generator of e-way bills in the country.
- Andhra Pradesh has been ranked first in the 2018 Ease of Doing Business, followed by Telangana and Haryana.
- The Indian Railways launched 'Mission Satyanishtha' and a programme on Ethics in Public Governance, in a first-of-its-kind event.
- The Parliament approved a legislation, fugitive Economic Offenders Bill, 2018 to help the government bring back fugitives involved in white-collar crimes to stand trial in India.
- Union Minister for Skill Development and Entrepreneurship Dharmendra Pradhan announced that the Centre is planning to set up one National Skill Training Institute (NSTI) in

- every State to meet the rising demand for skilled manpower in the country.
- India has become the Vice-Chair (Regional Head) of the Asia Pacific Region of World Customs Organisation (WCO) for a period of two years (from July 2018 to June 2020).
- The Telecom Commission has approved the Telecom Regulatory Authority of India's (TRAI) net neutrality recommendations that bar service providers from discriminating against internet content and services by blocking, throttling or granting them higher speed access.
- The Union Government has granted the Institutions of Eminence (IoEs) status to six institutions including 3 from Public Sector and 3 from Private Sector.

- Ministry of Housing and Urban Affairs has launched India Smart Cities Fellowship (ISCF) and Internship (ISCI) program that will provide the youth with an opportunity to experience the aspects of Urban planning and governance.
- The Union Environment Ministry has issued a notification setting noise standards for all airports across the country. The limits, however, exclude defence aircrafts, and those that are landing and taking off.
- Prime Minister Narendra Modi and South Korean President Moon Jae-in visited Noida and inaugurated the New Mobile Manufacturing Plant of Samsung at Noida, which will be the world's largest mobile factory.
- The Cabinet Committee on Economic Affairs (CCEA) has approved proposal for expanding the scope of Higher Education Financing Agency (HEFA) by enhancing its capital base to Rs. 10,000 crore and tasking it to mobilise Rs. 1,00,000 crore for Revitalizing Infrastructure and Systems in Education or RISE by 2022.
- Election Commission has launched Androidbased mobile application named 'cVigil' for citizens to report any violation of the model code of conduct during elections.
- The government has decided to sharply increase the Minimum Support Price (MSP) for Kharif crops. The MSP for common variety paddy, the most important Kharif crop, will be raised by Rs 200 over last year's Rs 1,550 per quintal.
- Union minister of chemicals and Fertilisers Ananth Kumar announced that the country's first e-waste recycling unit will come up in Bengaluru, Karnataka.

- The Archaeological Survey of India decided to allow photography within the premises of all centrally protected monuments/sites.
- Rajya Sabha has, for the first time in 76 years since it came into being, entered into a Memorandum of Understanding (MOU) with a foreign counterpart for promoting interparliamentary dialogue. Venkaiah Naidu has become the first Chairman of Rajya Sabha to sign such an agreement when he inked an MOU with the visiting President of the Senate of the Republic of Rwanda, Bernard Makuza.
- The National Security Guard will be the first central paramilitary force to opt for e-ticketing instead of the railway warrant under an agreement signed with the IRCTC.
- Airports Authority of India (AAI) will set up a state-of-the-art Civil Aviation Research Organization (CARO) at Hyderabad's Begumpet Airport to find indigenous solutions to meet the challenges posed by the growing air traffic and for enhancing safety, capacity and efficiency of aircraft operations in the country.
- Numaligarh Refinery Ltd (NRL) in Assam has become the first oil public sector undertaking (PSU) to adopt an online legal compliance system by introducing 'Legatrix'.
- The Bhitarkanika National Park (Odisha) has become the largest habitat of the endangered estuarine crocodiles in the country with a record number of their nesting sites spotted in it.

#### INTERNATIONAL

- India and Bangladesh signed several agreements for enhancing inland and coastal waterways connectivity between the two countries for trade and cruise movements.
- Israel Aerospace Industries (IAI) has won an additional \$777 million contract to supply LRSAM air and missile defence systems to seven ships in the Indian navy.
- India and Croatia signed two agreements to strengthen cultural and diplomatic cooperation between the two countries.
- India and Sri Lanka has signed two MoU for construction of 1200 houses through 50 model villages, using Indian grant assistance of 60 crore Srilankan rupees.
- India and Azerbaijan have agreed to take measures to enhance bilateral trade relations.
- Delhi government signed a twin-city agreement with the government of Moscow for cooperation in various fields like environment, culture and education, for the next 3 years.
- UNICEF and NASSCOM Foundation have signed an agreement to strengthen child rights through "meaningful business interventions.
- The government of India and Asian Development Bank (ADB) signed a \$110 million loan to finance the upgrade of 2,800 kilometers all-weather rural roads in Madhya Pradesh.

- India and Russia signed the \$5 billion S-400 air defence system deal during the annual bilateral summit between Prime Minister Narendra Modi and Russian President Vladimir Putin at Hyderabad House.
- Asian Development Bank (ADB) and the Government of India signed a \$150 million Loan Agreement in New Delhi to establish a Global Skills Park (GSP) in Madhya Pradesh.
- The government of India and the Asian Development Bank (ADB) signed \$240 million loan for providing safe and sustainable drinking water to people of West Bengal.
- The world's largest airport terminal "under one roof" with a capacity to serve 90 million passengers has been officially opened in Istanbul, Turkey.
- The 20<sup>th</sup> Water, Energy, Technology, and Environment Exhibition (WETEX) 2018 was held in Dubai.
- A Chinese company has tested the 'world's largest' cargo drone Feihong-98 (FH-98) which can carry a payload of 1.5 tonnes (1,500kg).
- Canada has become the second country after Uruguay to legalize possession and use of recreational cannabis.
- India and China have launched their first joint programme for Afghanistan to train its diplomats.
- India has been elected to the United Nations' Human Rights Council with the highest vote among all candidates.
- Ukraine began a series of large-scale air force exercises with the United States and other NATO countries.
- The 13<sup>th</sup> Annual Summit between India and Japan was held in Tokyo.
- Second Plenary Session of '2<sup>nd</sup> International Conference on Primary Health Care was held in Astana, Kazakhstan.
- The first trilateral meeting among India, Afghanistan and Iran of the Coordination Council of the Chabahar Agreement took place in Tehran, Iran.
- The 27<sup>th</sup> IAEA Fusion Energy Conference (FEC 2018) has started in Gandhinagar, Gujarat.
- The 17<sup>th</sup> Council of Heads of Government, CHG, meeting of the Shanghai Cooperation Organization (SCO) was held in Dushanbe, Tajikistan.
- According to an Asian Development Bank (ADB) report titled 'Asian Economic Integration Report 2018', most of the international migrants in 2017 were from India, followed by China and Bangladesh
- The 2018 Global Hunger Index (GHI) indicates that the level of hunger and undernutrition worldwide falls into the serious category, at a value of 20.9, down from 29.2 in 2000. As per the index, India was ranked 103<sup>rd</sup>.
- The World Bank released the Human Capital Index (HCI) as part of the World Development Report 2019. Singapore topped the poll after it was highly rated for its universal health care

- system, education exams results and life expectancy figures. It is followed by South Korea, Japan, Hong Kong and Finland. India was ranked at the 115<sup>th</sup> position.
- Japan's passport has been named the most powerful in the world, overtaking Singapore, according to the Henley Passport Index 2018.
- Apple displaced Google to become the top brand in the world in 2018 in the top 100 brands globally.
- India and Morocco signed an MoU for deepening cooperation between MSME sectors of the two countries in Rabat, Morocco.
- India and Niger signed an MoU for the implementation of Mahatma Gandhi International Convention Centre (MGICC) in Niamey, Niger with the Indian government's grant assistance.
- India and Morocco signed the revised Air Services Agreement between the two countries enabling greater connectivity through a modernized agreement.
- India and Sri Lanka signed an MoU for construction of a 5000-metric ton temperature controlled warehouse in Dambulla, Sri Lanka.
- A Loan Agreement for IBRD Credit of US\$74 million equivalent for the Uttrakhand Workforce Development Project (UKWDP) was signed between India and the World Bank.
- Bangladesh's Cabinet has approved a draft agreement with India to enable New Delhi to use the Chittagong and Mongla ports for the movement of goods to and from northeast India.
- The Delhi government signed an MoU with the Seoul Metropolitan Government to work closely in the fields of environment, tourism, wastewater and solid waste management, infrastructure and public health.

India and France have signed an implementation agreement on 'Mobilise Your City' (MYC). Mobilise Your City (MYC) is part of an international initiative which is supported by the French and the German Governments and was launched at 21st Conference of Parties (COP21) meeting.

- The MYC aims at supporting three pilot cities viz. Nagpur, Kochi and Ahmedabad in their efforts to reduce their Green House Gas (GHG) emissions related to urban transport by implementing urban mobility plans at local level and to help India at national level to improve their sustainable transport policy.

The RBI has reviewed the arrangement and issued revised directions under Section 35 A of the Banking Regulation Act, 1949 in the form of 'Internal Ombudsman( IO) Scheme, 2018.

It states that All Scheduled Commercial Banks in India having more than ten banking outlets (excluding Regional Rural Banks), are required to appoint IO in their banks.

- The Banking Ombudsman Scheme is an expeditious and inexpensive forum for bank customers for resolution of complaints relating to certain services rendered by banks.
- All Scheduled Commercial Banks, Regional Rural Banks and Scheduled Primary Co-operative Banks are covered under the Scheme.
- HDFC ERGO, India's third-largest non-life insurance provider in the private sector, announced the launch of 'E@Secure', a Cyber Insurance Policy for individuals. This policy aims at providing comprehensive protection to individuals and their families against any cyberattacks, cyber frauds or digital threats that could lead to a financial loss and or reputational loss.
- National Bank for Agriculture and Rural Development (NABARD) has sanctioned an amount of Rs.335 crore under the Rural Infrastructure Development Fund (RIDF) to West Bengal.

Prime Minister Narendra Modi launched the India Post Payments Bank (IPPB) at Talkatora Stadium in New Delhi. IPPB is the largest payments bank in the country by network size.

- Federal Bank has received the regulatory nod to open offices in Bahrain, Kuwait and Singapore.
- Jana Small Finance Bank announced the commercial launch of its banking operations, the last microfinance company to convert itself into a small finance bank (SFB), three years after the Reserve Bank of India (RBI) gave its in-principle approval.
- Oxigen and Fincare Small Finance Bank signed an agreement to roll out the Branchless Banking services, using Oxigen's flagship Point of Sale device called the Oxigen Micro ATM Super PoS.

The finance ministry has approved an infusion of Rs.11,336 crore in five state-owned lenders including PNB, Corporation Bank and Andhra Bank to help them meet the regulatory capital requirement.

- State Bank of India and National Bank for Agriculture and Rural Development (NABARD) have joined hands to provide collateral-free credit through Joint Liability Groups (JLGs) in Telangana.
- The Reserve Bank of India (RBI) has made it compulsory to incorporate purchaser's name on the face of payment instrumentalities like demand draft, pay order, banker's cheques and other instruments to prevent money laundering.
- HDFC securities announced the launch of Mutual Funds transactional capabilities on Facebook Messenger through their virtual assistant, Arya.

Airtel Payments Bank has received requisite approvals from the Reserve Bank of India (RBI) to begin taking new customers.

 The development comes nearly seven months after Airtel, along with Airtel Payments Bank, came under fire for allegedly opening payments bank accounts of its mobile subscribers without their consent

India has become the 69th shareholder of the European Bank for Reconstruction and Development (EBRD).

- European Bank for Reconstruction and Development is a multilateral development bank set up in 1991.
- Headquarters: London UK
- Asian Development Bank (ADB) has approved 503-million US Dollar lining project of the Son canal in Shahabad-Bhojpur region of Bihar which would benefit the agriculture sector immensely in the region.
- The Reserve Bank of India has announced that the licence of Alwar Urban Co-operative Bank in Alwar, Rajasthan has been cancelled as it is not in a position to pay its depositors in full as and when their claims accrue, among other reasons.

In a move aimed at promoting digital transactions, the Reserve Bank of India (RBI) has released operational guidelines to facilitate payments among prepaid instruments (PPI) such as mobile wallets.

 Currently, a mobile wallet does not allow customers to send or receive money from a wallet run by another company.

TCS became the world's largest pure-play information technology (IT) and consulting firm servicing megabanks and insurers.

The Reserve Bank of India (RBI) has allowed stateowned oil companies to borrow long-term working capital from overseas.

 Till now oil marketing companies were not allowed to raise External Commercial Borrowing (ECB) for working capital needs on a long-term basis.

IFC, International Finance Corporation, the World Bank's lending arm, has launched its \$1 billion masala bond programme in the US and Europe. These bonds are aimed at funding the rapidly expanding investment activities of IFC in India.

- Masala bonds are rupee-denominated borrowings issued overseas.
- As per the IMF's latest report, India is projected to grow at 7.3% in 2018 and 7.4% in 2019.
- As per the RBI, India's external debt declined 2.8% to USD 514.4 billion at June-end over the previous quarter on account of a decrease in commercial borrowings, short-term debt and nonresident Indian (NRI) deposits.

- According to the data released by Central Statistics Office (CSO), Index of Industrial production (IIP) grew at 6.6% in July on the back of good performance by the manufacturing sector and higher offtake of capital goods and consumer durables.
- The government of India has doubled the monetary limit to 20 lakh rupees for filing loan recovery application in the Debt Recovery Tribunals (DRT) by banks and financial institutions.
- Indian economy grew by 8.2% in the first quarter (April-June) of the current fiscal, the highest in over two years.
- India ranks 158th in the world for its investments in education and health care, according to the first-ever scientific study ranking countries for their levels of human capital. Finland topped the list, followed by Iceland and Denmark.
- India ranks third globally in terms of number of family-owned businesses with 111 companies having a total market capitalisation of \$839 billion. India closely follows China with 159 firms

- and the US with 121 firms, according to the 'Credit Suisse Family 1000 in 2018' study, published by the Credit Suisse Research Institute (CSRI).
- The Reserve Bank of India has released its annual report. Due to the evolving economic conditions, real GDP growth for 2018-19 is expected to increase to 7.4% from 6.7% in the previous year.
- The government has raised interest rates on Small Savings Schemes (SSS), including National Savings Certificate (NSC) and Public Provident Fund (PPF) by up to 0.4% for the October-December quarter, in line with rising deposit rates in the banks.
- The Union Cabinet approved new Umbrella Scheme 'Pradhan Mantri Annadata Aay Sanrakshan Abhiyan, PM-AASHA. The new Umbrella Scheme includes the mechanism of ensuring remunerative prices to the farmers.
- The Union Government has appointed former Reserve Bank of India governor Bimal Jalan as the head of the panel that has been tasked with selecting India's next chief economic advisor (CEA).
- The Government has decided to make the Pradhan Mantri Jan Dhan Yojana (PMJDY) an open-ended scheme and added more incentives to encourage people to open bank accounts. The Finance Minister Arun Jaitley stated that the overdraft facility has been doubled from Rs.5,000 to Rs.10,000 under the Yojana.
