US President signs executive order raising tariffs on 68 countries & EU

US President Donald Trump signed an executive order raising tariffs on dozens of key trading partners around the world. Under the new policy, 68 countries and the 27-member European Union will face a default 10 per cent tariff.

Russia Officially Ends Commitment to 1987 INF **Nuclear Arms Treaty**

Russia has officially declared it no longer considers itself bound by the Intermediate-Range Nuclear Forces (INF) Treaty. The 1987 arms control deal had banned ground-launched missiles with ranges between 500 and 5,500 kilometres.

Trump raises U.S. tariffs on Indian imports to 50%

U.S. President Donald Trump has signed an executive order imposing an additional 25% tariff on imports from India, in response to India's importing of oil from Russia. This is over and above the 25% tariff on Indian imports that Mr. Trump approved on July 31.

Canada plans to recognize Palestinian State

Canada is planning to recognise a Palestinian state at the United Nations in September, becoming the third G7 nation to make such an announcement in recent days.

Myanmar announces formation of new government

Myanmar's National Defence and Security Council, NDSC has formed a new union government and State Security and Peace Commission. The Union government is led by U Nyo Saw as Prime Minister.

India Launches Collaborative Initiative with UN WFP to Strengthen Rice Fortification

India has launched a new collaborative initiative with the support of the UN World Food Programme to strengthen Rice Fortification and Supply Chain Management in Nepal.

Pakistan: Over 300 people died due to monsoontriggered rains

In Pakistan, over 300 people, including 140 children, have died and over 715 people have been injured since June 26 due to monsoon-triggered rains and landslides.

Australia and Japan Sign Largest-Ever Defence Deal Australia and Japan have signed their largest-ever defence agreement. Under the deal, Australia will acquire 11 advanced Mogami-class stealth frigates from Japan's Mitsubishi Heavy Industries to upgrade its naval fleet.

Thailand and Cambodia sign a ceasefire agreement . Thailand and Cambodia signed a ceasefire agreement during an extraordinary General Border Committee meeting in Kuala Lumpur.

Azerbaijan and Armenia Sign Landmark Agreement

Azerbaijan's President Ilham Aliyev and Armenian Prime Minister Nikol Pashinyan have signed an agreement aimed at ending decades of conflict.

Bangladesh elections to be held in February next year Bangladesh's Chief Election Commissioner (CEC) has said that the upcoming 13th Jatiya Sangsad (National Parliament) elections will be held in the first half of February next year.

Australia to Recognize Palestinian State

Australian Prime Minister Anthony Albanese has announced that Australia will formally recognise the State of Palestine at the 80th Session of the United Nations General Assembly in September, marking a significant shift in the nation's foreign policy.

US & China Agree To Extend Trade Truce Until November 10

The US and China have agreed to extend their trade truce until November 10, just hours before new tariffs were set to take effect. In a joint statement, both countries said they will pause the planned tariff increases for another 90 days.

UN negotiations fail to reach global consent to end

plastic pollution Efforts to reach a global treaty to end plastic pollution in Geneva have failed once more, as UN negotiations ran into deadlock despite continuing overnight past the deadline.

Alaska Summit Ends Without Deal on Ukraine Conflict Presidents Donald Trump and Vladimir Putin said that they made progress in three hours of talks in Alaska, moving closer to finding an end to the Ukraine War, but did not announce an immediate ceasefire.

Thousands of Palestinians leave Gaza City fearing Israeli offensive

Fearing an imminent Israeli ground offensive, thousands of Palestinians have left their homes in eastern areas of Gaza City, now under constant Israeli bombardment.

Afghanistan, China, Pakistan Agree to Extend CPEC The Foreign Ministers of Afghanistan, China and Pakistan have agreed to expand their cooperation in multiple fields, including the extension of the China-Pakistan Economic Corridor (CPEC) to Kabul.

European postal services suspend shipment of packages to US over import tariffs

Postal services in Germany, Denmark, Sweden, and Italy have announced that they will halt most merchandise shipments to the United States with immediate effect.

Nepal joins International Big Cat Alliance Nepal has officially joined the International Big Cat Alliance (IBCA), an India-led global initiative to protect seven species of big cats.

South Korea bans phones in school classrooms nationwide South Korea has passed a bill banning the use of mobile phones and smart devices during class hours in schools · becoming the latest country to restrict phone use among children and teens. The law, which comes into effect from the next school year in March 2026

Argentina Eases Entry Rules for Indian Citizens

South American nation Argentina has relaxed its entry rules for Indian citizens, allowing those with a valid US tourist visa to travel without needing to apply separately for an Argentine visa.

France, Germany & UK trigger 30-day process to reimpose UN sanctions on Iran

France, Germany, and the United Kingdom, known as the E3, have triggered a 30-day process to reimpose UN sanctions on Iran over its nuclear program. The move starts a countdown at the UN Security Council.

Trump administration approves sale of 3,350 ERAM missiles to Ukraine

The Donald Trump administration has approved the sale of 3,350 Extended Range Attack Munitions (ERAM) missiles to Ukraine.. The ERAM missiles, which have a range of 150-280 miles, could be delivered later this year.
