South Korea, Japan to Resume Naval Rescue Exercise After Nine Years

South Korea and Japan have agreed to resume their bilateral naval search and rescue exercise for the first time in nine years, aiming to strengthen military exchanges and trust.

BLA Announces Second Phase of 'Operation Herof' in Balochistan

The Baloch Liberation Army has announced the launch of the second phase of Operation Herof across Balochistan, describing it as decisive resistance against Pakistani military and administrative structures.

US witnesses widespread protests

In the US, protesters across the country are calling for 'no work, no school, no shopping' as part of a nationwide strike, to oppose the Trump administration's immigration crackdown.

US to cut tariffs on India to 18%

U.S. President Donald Trump has announced a trade deal with India that slashes U.S. tariffs on Indian goods to 18% from 50% in exchange for India halting Russian oil purchases and lowering trade barriers.

Spanish govt plans to ban social media for children below 16

Spanish Prime Minister Pedro Sanchez has announced that his government plans to ban accessing social media platforms for children under the age of 16, citing concerns about online safety and harmful digital content.

India Joins UN Honour Roll by Paying 2026 Dues Early

India has joined the United Nations Honour Roll after promptly paying its 2026 dues of USD 35.187 million within 30 days,

US and Russia Exit New START Treaty

The United States and Russia are no longer bound by the New Strategic Arms Reduction Treaty (New START), which expired on February 5, raising global security concerns. The pact, signed in 2010 and extended to 2026, limits deployed nuclear warheads and strategic delivery systems.

Trump signs executive order to impose tariffs on countries trading with Iran

US President Donald Trump has signed an executive order renewing the national emergency on Iran and creating a new tariff system targeting countries that buy goods or services from Tehran.

Russia & US agree to re-establish high-level military dialogue after a gap of four years

The United States and Russia have agreed to re-establish high-level military dialogue for the first time in more than four years. High-level military communication was suspended in late 2021

Canada & France open Greenland consulates

France & Canada have opened consulates in Greenland's capital Nuuk, in a show of support for their NATO ally Denmark amid renewed demands from US President Donald Trump to acquire the Arctic territory.

South Korean & US commences joint aerial exercise 'Buddy Squadron'

The South Korean and the United States' air forces have held a joint aerial exercise at Osan Air Base in Pyeongtaek. The "Buddy Squadron" exercise is aimed at enhancing interoperability and integrated tactical capabilities between the two allies.

2,034 candidates contest Bangladesh's 13th Jatiya Sangsad election on February 12

In Bangladesh, a total of 2,034 candidates, including 275 independents, have contested the 13th Jatiya Sangsad (National Parliament) Election and Referendum scheduled for the 12th of this month.

European Parliament Clears €90 Billion Support Package for Ukraine

The European Parliament has approved a €90 billion loan package to support Ukraine during 2026–27, as the conflict with Russia enters its fifth year.

UK Pledges Fresh Air Defence Support for Ukraine

Britain has pledged hundreds of millions of dollars in air defence assistance to Ukraine to counter Russian attacks on energy infrastructure. Around \$200 million will go to a NATO-backed scheme to procure U.S. weaponry, while the UK will also supply 1,000 British-made lightweight missiles worth over \$500 million.

BNP to Form Government After Landslide Win in Bangladesh

The Bangladesh Nationalist Party is set to form the next government after securing a sweeping victory in the 13th parliamentary elections, crossing the two-thirds majority mark.

US and Taiwan Finalise Major Trade Agreement

The Trump administration has concluded a trade deal with Taiwan under which Taipei will remove or reduce 99 percent of its tariff barriers.

US Deploys Aircraft Carrier to Middle East Amid Iran Tensions

US President Donald Trump has confirmed the deployment of the world's largest aircraft carrier, USS Gerald R. Ford, from the Caribbean to the Middle East to bolster American military presence.

Cyclone Gezani kills 59 in Madagascar

Cyclone Gezani has killed at least 59 people in Madagascar and forced more than 16 thousand residents from their homes.

U.S. and Uzbekistan sign critical minerals pact

The U.S. government has signed an agreement "Joint Investment Framework" with Uzbekistan to secure better access to the Central Asian country's critical minerals.

U.S. Supreme Court rejects Trump's global tariffs

The U.S. Supreme Court has struck down President Donald Trump's sweeping tariffs that he pursued under a law meant for use in national emergencies.

Venezuela's Legislature Approves Amnesty Bill Amid Rights Concerns

Venezuela's National Assembly has passed an amnesty bill aimed at freeing people detained for political reasons, and interim President Delcy Rodríguez signed it into law.

The measure is seen as a step toward reconciliation and has already led to hundreds of releases under the new law.

US President Hikes Global Tariffs from 10% to 15% After Court Setback

US President Donald Trump has raised the global tariffs from 10 percent to 15 percent after a big setback in the Supreme Court.

Japan to deploy missile systems on island near Taiwan by 2031

Japan's Government plans to deploy surface-to-air missiles on one of its remote western islands near Taiwan by March 2031, the country's Defence Minister said.

It is the first time Japan has specified the timing of the deployment.

Bangladesh: President Summons First Session of 13th Parliament on 12 March

President Mohammad Shahabuddin has summoned the first session of the 13th Parliament for 12th March, nearly a month after the Bangladesh Nationalist Party (BNP) formed the government following its victory.

U.S. and South Korean Militaries will have joint drills in March

The U.S. and South Korean Militaries will conduct their annual springtime exercises Freedom Shield from March 9-19, 2026 to bolster their countries' combined defence capabilities against a backdrop of a deepening diplomatic freeze with nuclear-armed North Korea.

Pakistan declares war against Afghanistan

Pakistan has declared an open war against Afghanistan after the Taliban administration said that its forces killed and captured several Pakistani soldiers during a cross-border offensive.

Jitendra Singh launches first open call under RDI Fund for high-risk technology commercialisation

Union Minister of State for Science and Technology Dr. Jitendra Singh has launched the first open call of the Technology Development Board (TDB) under the Research, Development and Innovation (RDI) Fund, marking a major step towards strengthening India's innovation ecosystem through structured, long-term financing for indigenous technologies.

India-U.S. interim trade framework

The United States and India have agreed on an interim trade pact framework, aiming to lower tariffs and boost economic cooperation. Under the interim trade agreement, tariffs on New Delhi will be reduced to 18%. As part of the deal, the US has withdrawn the additional 25 per cent duty it had imposed on Indian imports.

India has successfully test-fired the Agni-III intermediate-range ballistic missile from the Integrated Test Range at Chandipur in Odisha. The launch was conducted under the supervision of the Strategic Forces Command.

Centre lays down eligibility criteria for 'deep tech' start-ups

The Centre has revised the startup recognition framework to further strengthen the Startup India Action Plan. Under the revised framework, a startup will be defined as an entity that is up to 10 years from the date of incorporation or registration and has recorded a turnover not exceeding Rs 200 crore in any financial year since incorporation. For entities recognised as 'Deep Tech Startups', the eligibility window has been extended to 20 years, while the turnover ceiling has been raised to ₹300 crore for any such financial year.

Amaravati to Become India's First Quantum Valley

Union Minister for Science and Technology Dr. Jitendra Singh said Amaravati will soon emerge as India's first Quantum Valley. He, along with Andhra Pradesh Chief Minister N. Chandrababu Naidu, laid the foundation stone for the Amaravati Quantum Valley project in the state capital.
